APPLICATION

Applicant must have been working at Goodwill of Colorado for a minimum of 60 days, be an employee in good standing (not currently under any disciplinary action) and have demonstrated satisfactory attendance. If accepted into the Career Pathways Program, applicant will enter program on a 30-day trial basis, during which time the employee may elect to exit the program with no negative impact on future applications for reenrollment.

Employees may not enroll in more than one Career Pathway Program within a 12 month period.

Enrollment in this program may require a drug test and/or background check.

Each career pathway training will require a set class size and may be delayed until the minimum enrollment is reached.
