Goodwill's Retirement Plan—Grow Your Nest Egg

Did you know that Goodwill offers a retirement plan, with matching, for our employees? Currently, only 13 percent of our employees are taking advantage of the free matching investment from Goodwill.

What does this mean?

From your first day of employment with Goodwill (as long as you are 18+ years old), you can choose to deduct pre-tax or post-tax (Roth) dollars into your retirement account. Not only does this grow your retirement nest egg, but the amount you decide to invest can reduce the amount of federal income tax taken out of your paycheck. This is because your pre-tax retirement deduction is taken out of your pay before your income tax is deducted.

Here is how Goodwill matches your retirement plan investments, up to 2 percent.

Employee A –

Goodwill Contribution 3% Employee contributes 2% Goodwill Matches 2% Total combined investment = 7%

Employee C -

Goodwill contribution 3% Employee does not contribute Total investment = 3%

Employee B –

Goodwill contribution 3% Employee contributes 1% Goodwill Matches 1% Total investment combined = 5%

Employee D –

Goodwill contribution 3% Employee contributes 5% Goodwill Matches 2% Total investment = 10%

**Both the Goodwill 3% contribution and 2% match are available to employees after they have worked one year of at least 1,000 hours. GISC fringe employees may contribute to the plan but are not eligible for the Goodwill contribution and match. After three years of employment and 1,000 hours worked each year, or at age 65, you are considered "vested" the Goodwill's 3% contribution is fully yours.

PeakMed Acquired by One Medical

Our direct primary care provider, PeakMed, has been acquired by One Medical. For those of you who have established medical care with PeakMed, you received a letter in the mail to update you about this change. What do you need to do? Download the One Medical app, available on the App Store and Google Play and create an account. This will allow you to schedule appointments with your provider, see your medications and prescriptions, and much more.
